

HELIPAD IN PORTO MIRABELLO

Porto Mirabello has a helipad made available to Customers wishing to arrive by air; the flight is only permitted during **DAYLIGHT HOURS**

The cost of the service is 250,00 Euros + VAT 22%.

The request must be made at least 15 days prior to arrival, as this is a "PAPA 2" area
